## Five Awards to Be Presented at The Annual Awards Banquet and Dinner Dance in March.

The club's Annual Awards Banquet and Dinner Dance is here again. Vice President Rick Evans is working on the banquet details. The flyer for making your reservation can be found in this newsletter. A deadline of January 25, 2025, is set to enable all the preparation to be completed on time.

President Kurt Steidle is organizing a committee to review nominations for the awards. The categories remain the same as last year's.

The following are the award categories with a description of each:

**LCCC Lifetime Achievement Award**—One person, recognized annually, for the consistently outstanding leadership, participation, involvement and contributions to the club throughout their membership tenure. This award is based on achievement not attendance. Recognition should be limited to those individuals who have been members for 15 years or more.

**LCCC Outstanding Worker(s)**—Recognition of an individual or couple that consistently 'steps-up' to help in club activities throughout the year. Often, they go above and beyond in their efforts.

**LCCC Unsung Hero**—Recognition of an individual member that typically 'flies below the radar,' but consistently shows up, [participates and gets involved in a variety of club activities.

**Outstanding Leader(s)**—Recognition for an individual or couple who both actively participate in the club's various activities and events, including taking leadership/organizing roles in a variety of activities or events.

**Outstanding New Member**—Rookie recognition of an individual member who has recently joined the club (since July or the previous year). These new members have jumped in 'headfirst' to participate in activities or events and actively support the club.

## Front Page Feature Corvette— DeFelice's

#### I went in for an oil change and came out with an E-Ray...

It was just a year ago that we purchased our second Corvette, the 2017 Stingray Convertible. What a great car!! Something that we could drive like normal people, not the drag car that our C5 has become. Well, that didn't last long.

I've said to a number of you that I am a slow adopter. I'm usually a generation or three behind, once I like something, I stick with it. I hadn't really come to love the C8 and I am certainly not an electric vehicle kind of guy. So what did we do, we got ourselves an electric C8. Makes sense.

So here's the story. When the reveal for the E-Ray came out, I was already thinking, the C8 has bent too far to the European mindset and now they are going to screw it up by making it electric. Boy was I proven wrong!

I begrudgingly watched the reveal video and OMG!!! It was love at first sight. Not only did they keep the big ole engine in the rear, they also added the 160 HP electric motor in the front. In a stroke of brilliance for so many reasons, they made it AWD and decoupled the electric driven front wheels from the regularly powered rear wheels. They made no bones about it, the electric motor was not for economy, it is meant for pure performance enhancement (some of us can always use that). Beyond that, they also made it more of a touring car than the raw, unbridled performance machine that is the Z06. So here's a car in which we can comfortably take road trips, that's easy for us both to drive, and will allow me to piss off an unsuspecting Z06 light to light.



The specs on the car are incredible, but like one would expect, there were not that many produced and getting one was almost impossible. Also, if you could find one, they were priced in the stratosphere. Therefore, I put it out of my mind.



Well then came the fateful e-mail from Whitmoyer. It was an ad that indicated they got four Z06's and were selling them for \$10,000 off MSRP. What?? A Z06 for less than MSRP?? Assuming they would be scooped up quickly, I didn't reach out. But I had a service appointment for the C7 and decided to go see Matt Beaver about the black Z06. He told me that one was sold, the only one left was the red one. After a day or so thinking about it, I went back to let him know I only wanted black. He then said that he just got contacted by a dealer that is trying to unload a black E-Ray; I couldn't believe it! After showing a bit of interest, getting permission from Lisa, and haggling a bit, I bought it sight unseen.

I had never even driven a C8, but I couldn't pass up this opportunity.

When I arrived at Whitmoyer to pick it up, I saw that Carbon Flash Metallic paint sparkling in the sun and I may have shed a tear, peed a little, or maybe both. It is truly a gorgeous car. It has the body of the Z06, massive ceramic rotors, red calipers, huge performance tires (ZER package), all the ground effects, 3LZ, and more stuff than I can remember.

Regarding performance, while the Z06 will get you better numbers on a longer track, the E-Ray does the 0-60 in 2.5 seconds versus the Z06 in 2.6 seconds. Also, in the 1/4 mile, the E-Ray is 0.1 second quicker than the Z06. Based on Chevrolet's marketing department, the E-ray is currently the quickest Corvette ever produced. That is until the 2025 ZR-1 hits the streets...


